


### Rada Universal 12 V RMS 50/60 Hz Transformer





## **IMPORTANT**

Installer: This manual is the property of the customer and must be retained with the product for maintenance and operational purposes.

## INTRODUCTION

The Rada Universal 12 V RMS 50/60 Hz Transformers are designed to supply 12 V RMS 50/60 Hz to a range of Rada mono controls (that is, units that do not require connection to Rada Control Boxes) and consists of a short circuit proof safety isolating transformer.

The transformer enclosure is water-resistant, and intended for wall-mounting to a suitable flat dry surface (fixing screws are not supplied). This appliance is intended for permanent connection to the fixed electrical wiring of the mains electric system. The transformer must be connected to the electrical supply with a double isolating pole switch.

A mains 230 V RMS 50/60 Hz supply cable of 2 metre length is pre-connected, this must not be removed; do not renew the cable inside the box if damaged. Safe low-voltage 12 V RMS 50/60 Hz output is fuse-protected internally. This appliance is IP54 protected, provided protection caps are fitted to unused cable grommets.


